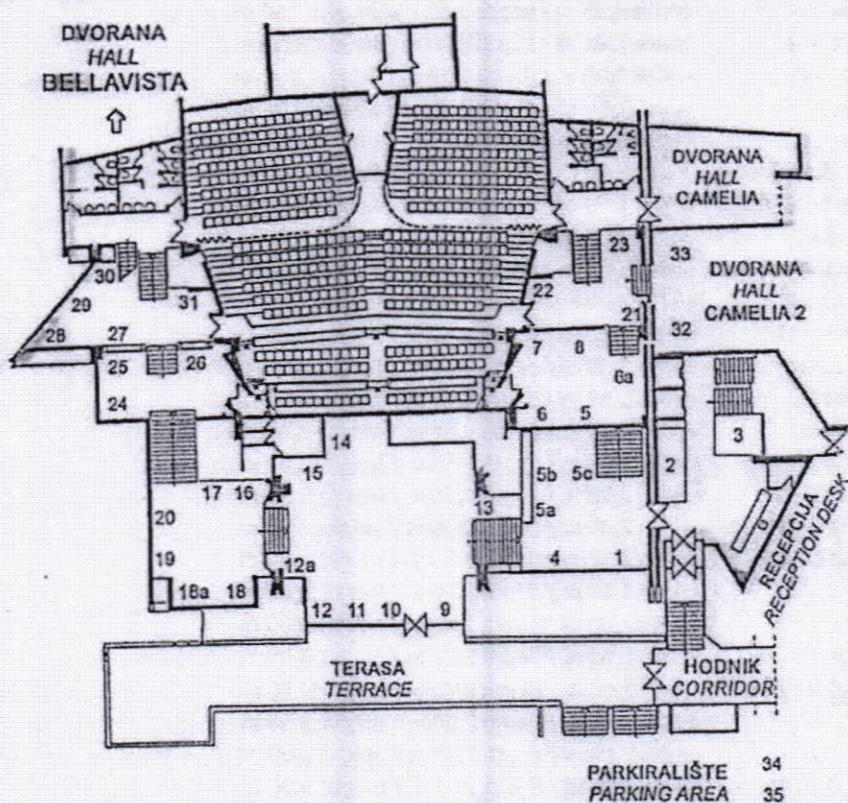

**Indoor Exhibition Space** is located around the Congress Hall of the Grand Hotel Adriatic and it is divided into thirty-nine booths of different size. Each booth is equipped with the following:
